

First, I recommend that the user listen to the audio and take notes, followed by keeping paper copy near to hand for ease of embedding desired info. Beginning with reasons to incorporate, it moves along through definitions, corporate ladder and structure, and bylaws. There is a necessity to have a registered agent and other mandates regardless of state in which incorporation occurs. Also provided is a more detailed description of the exceptions in two particular states. The author provides rather detailed comparisons of types of incorporation including benefits and tax considerations, including an exemplification type of Q & A. Definitions are clear and contextual. Concluding with clear warnings related to risk management and keeping personal assets separate from the business is a business startup checklist.
