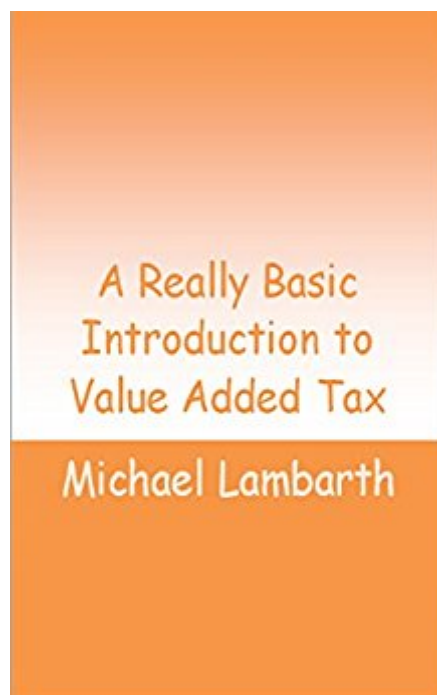

Not value for money for those shoppers outside of US region, like my case Malaysia. This book only comes with 53 pages, very plain mono color printing, printed with huge font maybe 16 points. With all these simplest clean stuff it cost me close to USD20 including shipping cost, USD 20 equivalent to Malaysia Ringgit about 90, with this price normally I can get better quality books and it normally comes in 1.5 - 2 inches thickness, this book now only about 0.5cm thicknees. Btw, with now Malaysia Ringgit seriously devalued and when vs USD is about 1 USD = MYR4.50, it is almost stopping majority Malaysian to shop in .com.
